1. Welcome

Debra Johnson welcomed attendees to the meeting of the Advanced Mobility Partnership (AMP) Executive Committee and began the meeting. Two new members were introduced. Ms. Johnson, RTD's CEO and General Manager, and Kay Kelly, CDOT's Director of Innovative Mobility. Other members (primary and alternate) introduced themselves.

2. AMP Overview and Initial Activities

Brian Welch provided highlighted the importance of implementing Mobility Choice Blueprint as a coordinated effort and continuing to collaborate on opportunities in the region. Mr. Welch provided a brief overview of the Mobility Choice Blueprint planning process.

Emily Lindsey reviewed initial activities of the AMP, highlighting 2020 work which included: identifying and assembling stakeholders, prioritizing tactical actions, forming three steering committees to identify next steps and initial roadmaps, developing the AMP Next Steps document, developing a brand a website, starting initial tactical action activities and ongoing coordination and conversation through the AMP Working Group on transportation technology-related efforts in the Denver region.

3. AMP Tactical Action Updates

Ms. Lindsey provided an overview of the Steering Committee and planning process and introduced the three focus area Steering Committees (Data and Data Sharing, Shared Mobility and System Operations).

Ashley Nysten provided the group an overview of the work on Data and Data Sharing priority tactical actions. She reviewed some of the recent work on discovery, including 1:1 interviews,

survey efforts, case study research (DOT and MPO) and stakeholder information sharing on current agency efforts.

Paul DesRocher provided the group an overview of the work on Shared Mobility priority tactical actions. He reviewed some of the recent work including: sharing RTD's emerging MaaS strategy and new partnerships with the working group and initiating AIM grant work which leverages the Transit app and integration between RTD and Bustang ticketing and trip planning.

Greg MacKinnon provided the group an overview of the work on System Operations priority tactical actions. He reviewed some of the recent work including: ongoing monitoring of regional TSP deployments, coordination with FHWA to host a virtual ICM workshop and the annual ITS inventory.
